<i>SUMMARY OF BENEFITS</i>	PATIENT COPAYMENT
<b>Class I - Diagnostic &amp; Preventive</b> Exams, Cleanings, Fluoride, X-rays, and Sealants	Covered at 100% when performed by the assigned DeltaCare dentist. (Subject to plan exclusions and limitations.)
<b>Class II - Restorative</b> Restorations, Endodontics, Periodontics, and Oral Surgery	Covered at 100% with a \$10 copayment per visit. <i>(Note: If a posterior tooth is restored with a composite (white) filling, the plan will cover the cost up to the amount allowed for a tooth to be restored by an amalgam (silver) filling. Any difference in cost will be your responsibility.)</i>
<b>Class III – Major</b> Crowns, Dentures, Partials and Bridges <i>(Implants are not covered)</i>	A \$10 copayment will be required per visit. Additional copayments will also apply.
<b>Annual Maximum &amp; Deductible</b>	No annual maximum or deductible.
<b>Orthodontia</b> Adults & Dependent Children <i>(Nightguards are not covered)</i>	Services must be provided by a DeltaCare orthodontist.  Copayments will apply, contact DeltaCare at (877) 577-5057 for specifics.
<b>Emergency Services</b> (Immediate pain relief)	All emergency services must be coordinated through your selected DeltaCare dentist.

The DeltaCare plan offers you and your family an affordable choice for quality dental care. Delta Dental/Washington Dental Service has contracted with a select network of dentists (both primary care dentists and specialists) who have agreed to provide a full range of benefits and high-quality care.

### ACCESSING CARE

#### How to use your DeltaCare program

When you enroll you will need to choose a Dentist from the list of contracted Deltacare Providers. After you have enrolled, you will receive a membership card that will have the address and telephone number of your DeltaCare dentist. To receive all necessary dental care, simply contact your assigned DeltaCare primary care dentist to make an appointment.

Your DeltaCare dentist is responsible for coordinating all specialty care. Either he/she will perform the specialty treatment, or refer you to a DeltaCare network specialist. In some unique cases, your dentist may refer you to a non-network specialist, but prior authorization is required.

***The DeltaCare program will not cover dental services that are not performed by your assigned DeltaCare office or properly referred to a DeltaCare specialist.***

You may change DeltaCare dentists by contacting the Delta Dental/Washington Dental Service DeltaCare unit and making your request by the 25<sup>th</sup> of the month.
