Your DeltaCare® USA managed care dental plan, administered by Delta Dental Insurance Company, makes taking care of your smile easy and predictable.

How to Use your DeltaCare Program

In Oklahoma, the DeltaCare USA program offers a choice of selecting a Dentist from our panel of Oklahoma DeltaCare USA Network Dentists, or you may choose a Non-Network Dentist. A list of DeltaCare USA Network Dentists can be obtained by accessing the DeltaCare USA Dentist Directory at deltadentalins.com. You are responsible for verifying whether the treating Dentist is a Network Dentist. To confirm a Dentist's participation in the network, you should contact the Customer Service department at 844.282.7639.

When you visit a DeltaCare USA dentist, you'll be responsible only for your defined copayment for covered benefits. You may receive treatment from a non-DeltaCare USA dentist, but you may pay more than the applicable copayments of your plan, and your out-of-network benefits would apply.

Schedule your appointment

After you have enrolled, you will receive a membership packet that includes an identification card and an Evidence of Coverage booklet that fully describes the benefits of your dental program. Simply call any DeltaCare USA network dentist to make an appointment.

Finding a DeltaCare USA Dentists

Dental Emergencies

The Enrollee should contact a DeltaCare USA Dentist for Emergency Services for covered dental procedures whenever possible. If the Enrollee is unable to reach a DeltaCare USA Dentist for Emergency Services, the Enrollee should call Customer Service at 844.282.7639 for assistance in obtaining urgent care.

Confirmation of Treatment and Cost (Formerly called Predeterminations)

When your dentist recommends treatment, we encourage you to ask them to submit a Predetermination. Once submitted, you'll receive a Confirmation of Treatment and Costs (Confirmation). A Confirmation details your dentist's specific treatment plan, what your benefits pay, and gives you an accurate out-of-pocket estimate.
